What to notice

This is the public record that exists once the Articles of Organization are accepted. Anyone can pull it from Find a Business, and banks and payers do. It is the first document in the paper trail: the EIN interview, the bank, and every payer form ask for the exact legal name and the registry date shown here.

Read the history table twice. In my second year the annual report slipped, the state administratively dissolved the company on 03-07-2024, and a reinstatement filing on 04-17-2024 put it back to Active. The registry keeps that line forever, and a credentialing analyst who pulls the record will see it. Calendar the renewal the day you file; it comes due on the anniversary of the registry date.

The registered agent here is a commercial agent in Portland. That is a choice, not a requirement; step 2 of the LLC series covers the trade-off between naming yourself and paying an agent.
